Description

Hard, oblong, opaque, gelatin capsule with scarlet cap and gray body, printed with "Pacritinib 100 mg" on the cap and "C78837" on the body

Storage and handling

Store at room temperature, below 30°C (86°F). Keep the bottle tightly closed and protect from light. Store in original package. Dispense in original package or in a light-resistant container.

Dosing

The recommended dosage of VONJO is 200 mg orally twice daily, with or without food. Swallow capsules whole—do not open, break, or chew capsules.
